Terms & Conditions:

1. This contract will guarantee that semen will be provided from the stud listed above. Payment must be paid in full for whatever the agreed amount notated in the contract.
2. Live birth of 2 or more puppies will be considered a completed litter. In the rare event of a single puppy, one of the following will apply:
 - a. If stud fee was paid in full, a free repeat breeding will be given on the next heat cycle to the same dam. Dam owner will be responsible for ALL shipping and vet collection costs.
 - b. If pick of the litter option is chosen, the single puppy from original breeding will be sold and earnings will be split between owners of dam & stud for services rendered.
3. If pick of litter was chosen, and there are only 2 surviving puppies in the litter, a free rebreed will be given if the value of the puppy is determined to be equal to or greater than value of stud fee. If the pick puppy value is less than stud fee, then the difference of the value of the puppy and the price of the stud fee is due at the time of rebreeding the same female. Value of puppy will be determined by sale price. AKC litter registration application will be approved once pick puppy is received by stud owners. Pick puppy will be chosen by stud owners by 6 weeks of age. Stud owners will be responsible for shipping costs of chosen puppy.
4. No fee will be refunded should your dam fail conceive. In such case, stud owner should receive written notification on a letterhead from a licensed Veterinarian with description of dam confirming no pregnancy or delivery took place within 7 days from estimated due date. A return of service will be given in the next heat cycle to the very same dam. If the dam changes ownership or fails to conceive after return of service, this contract is null and void. Dam owner is responsible for any medical costs acquired as a result of rebreeding or conceiving a litter, puppy costs including delivery but not limited to vet visits, food, training supplies, AKC registration, etc.....

In conclusion, the Dam owner is responsible for all veterinary charges & shipping costs as needed for insemination. Dam owner agrees to progesterone testing for optimal breeding time accuracy.

Any public slander or harassment towards the stud or Gucci Frenchies is prohibited. We cannot control the number of pups produced or whether the dam will conceive. We do not tolerate any public bashing, slander, or bad mouthing our studs or business. Doing so is subject to penalties up to \$10,000 USD.

Any changes from this standard stud contract will be noted below in the "Comments/Changes" section below and will be agreed to by both parties once contract is signed. A party's signature of this contract acknowledges acceptance of all terms by both parties.

Should any contractual dispute occur, parties will select a non-interested third party to negotiate a settlement resolution. Any disputes arising from or about this contract that cannot be settled out of court, the proper venue for any court action will be taken in Polk County, Iowa. All court costs and expenses will be paid by the dam owner.

By signing this contract and using our stud services, you, the buyer agree that you have read, comprehend, and accept the agreement placed in this contract. It is understood that this contract only applies to the original buyer and seller and is nontransferable. It is further understood that there are no other warranties, either expressed or implied to the said dog/puppy except as set forth in this agreement. By signing this health contract, the buyer agrees and accepts all terms and conditions implied in this contract.
